
In 2020, 633 households and 20 churches and organizations gave over \$885,765 to sustain Covenant Point's ministry, as well as to invest in its good future. This allowed us to avoid layoffs, debt and deferred maintenance. We are overwhelmed, humbled and filled with gratitude. On behalf of all whose lives will be blessed through the ministry of Covenant Point, thank you!

Sabbath and work

The severe disruption and losses also opened up opportunities for renewal among staff, as well as in our site, facilities and programs:

- Fall and winter cabin rentals

Covenant Harbor

A time of transition

2020 was a year of big change. The transition from one executive director to another is a noteworthy adjustment for a camp. Covid also shifted Covenant Harbor from being a large camp to a small camp nearly overnight. Programs were cancelled, staff reduced, responsibilities reassigned and plans adjusted.

A time of crisis

Covid remains a serious threat. Normally, we serve 26,000+ quests annually. During the last 12 months, we served 2,850 guests. Meals dropped from 102,000 to 4,800. Operational revenue decreased by \$2.9 million. Across all measures, we experienced devastating declines. We implemented early and severe cost cuts and sought responsible ministry and revenue where we could, but it was not enough. We still needed to fundraise over \$1 million to survive. Nearly all staff energy was/is redirected exclusively to survival efforts.

A time of collaboration

Our challenging year was made easier because we were not alone. Harbor Point Ministries, Covenant Point and Covenant Harbor worked together to navigate new strategies and paths. The ECC reached out with grants and consultation. Our churches and donors provided incredible support to help us survive. We formed new partnerships in the community. Each played a critical role in our survival.

A time of gratitude and hope God has protected this ministry and given us unexpected opportunities.



Thanks and glory to God for ministry and service in 2020:

- 815 summer day-campers safely and creatively served
- 290 individuals participated in summer family getaways
- A family-focused retreat in October with 40 participants
- Pastor and family getaways in fall, winter and spring
- A few rental groups
- Covid testing and vaccine administration support in partnership with the Walworth County Health Department

I believe the worst is behind us. We will survive. Since May 2020, our faithful donors, churches and partners have given over \$1 million. We have a gap of less than \$80,000 to reach our fundraising target. Our cost cutting is on pace and we have stayed out of debt.

I expect our return to normal to take over a year. Yet, we see signs of hope. 2021 summer camps are nearly full (at reduced capacity) and churches and schools are slowly rebooking. Our staff are battered, but unified and hopeful we can serve more campers and guests soon.
